Membership Types

FULL SIGNATURE MEMBERSHIP

A Full Signature Membership allows sportsman access to all of Providence Hill's premier shooting facilities. Whether you plan on sharpening your skills, enjoying a day with friends, or making the most of the outdoors year-round, this membership gives you the freedom to shoot, train, and enjoy the sporting lifestyle without limits.

**This membership does not include fishing but can be added for an additional \$1,650.*

LEGACY MEMBERSHIP

A Legacy Membership includes all the benefits of a Full Signature Membership, with the added advantage of having your initiation fee waived. This exclusive benefit is extended to immediate family members of current Providence Hill members, welcoming the next generation into the Providence Hill community.

**This membership does not include fishing but can be added for an additional \$1,650.*

BUSINESS MEMBERSHIP

Business Membership in The Sporting Club at Providence Hill allows a Business to name a Primary Member and allows up to five Additional Business Memberships for additional yearly fees. Additional Business Members enjoy the same privileges of membership as Individual Members. Like all Individual Memberships, privileges are extended for up to three named immediate family members of the Primary Business Member and each Additional Business Member. The business retains the rights to all memberships and can transfer them as necessary. For example, if an employee is assigned membership and is transferred out of state, the business can transfer that membership to a new employee by making an application and payment of a nominal transfer fee.

Specific Benefits of Business Membership:

- **10% Discount on Group Shoot Fees** for all Events held by Business at the Club.
- The larger the group joining the Club, the lower the average cost.
- The Business or the individual may pay for the annual membership fees and/or monthly expenses of its Primary Member and/or Additional Business Members.

JUNIOR MEMBERSHIP

A Junior Member is under the age of 35 and has the advantages of regular Members except that the annual Membership Fee has been lowered from the regular annual membership period to \$2,500 (fishing memberships are not included). Once a Junior Members reaches 35, the Member will be treated as a regular Member at the time of the next annual renewal. A limited number of these Memberships are available so check with the Clubhouse for availability. This Membership is an exceptional value for our young, devoted sportsmen.

OUT-OF-STATE MEMBERSHIP

An Out-Of-State Member's primary residence is located outside of Mississippi and the Member carries an out-of-state driver's license. Designed for those who reside outside the area, the Out-of-State Membership offers all the privileges of our Full Signature Membership at an annual fee that is 30% lower than the resident membership along with being excluded from the required food minimum for In-State Members. This Membership is an exceptional value for frequent travelers to Mississippi.

1.I wish to engage and/or participate in outdoor activities, including, but not limited to, Shooting Sports, Archery sports, Hunting, Fishing, Boating, WaterBlob (high impact activity), Stand up Paddleboarding, and/or ATV and Golf Cart riding (collectively the “Activities”) on property owned, leased or licensed by WCT Providence Hill Holding LLC.

2.I understand and accept that my engaging or participating in any or all of the Activities exposes me to many risks and dangers. Some of the risks which may be present or occur include, but are not limited to:

- o the hazards of hunting, shooting and archery sports in general, including but not limited to malfunctions of weapons or ammunition that can result in explosions and misfiring causing traumatic physical damage to the face, head, chest, or neck;**
- o the hazards of using tree stands or hunting blinds;**
- o the hazards of self-inflicted wounds by firearms and/or bows;**
- o the hazards of bow misuse of firearms and/or bows by others, including injury or death resulting from firearm and/or discharge;**
- o physical pain and bruising of the arm, face, cheek, chest, or shoulder area caused by firearm and/or bow recoil;**
- o hearing damage resulting from firearm noise;**
- o eye damage resulting from firearm and/or bow use;**
- o hazards resulting from the exposure to lead and other materials used in hunting and shooting sports;**
- o the hazards of being exposed to the forces of nature including snow, ice, rain, lightning, wind, sun, and others not named;**
- o the hazards of traveling in a boat or vehicle or on an ATV or golf carts whether driven by me or not;**
- o the hazards of using the Water Blob jumping platform, risk of severe injury, paralysis or death;**
- o The hazards of the any lake activity and drowning;**
- o the hazards of participating in fishing and boating activities;**
- o the hazards of using the playground, risk of injury, paralysis, and death;**
- o the hazards of participating in any and all types of outdoor activities;**
- o and the hazards of any participant in the Activities failing to abide by the rules and policies of Providence Hill related to the Activities and to otherwise exercise reasonable prudence and care.**

3.I understand and accept that these risks expose me to, but are not limited to, the following consequences: death, serious neck, spinal or other bodily injuries which may result in complete or partial paralysis, brain damage, serious injury to my musculoskeletal system and serious injury to other aspects of my general health and well-being. I also understand that the risks in engaging or participating in the Activities include not only the foregoing physical injuries, but also impairment of my future abilities to earn a living, to engage in business, social and recreational activities, and generally to enjoy life.

4.Understanding the risks mentioned above and understanding that the Activities may subject me to rigorous physical exertion, I hereby state that I am physically fit to participate in these activities.

5.In consideration of my being permitted to engage and/or participate in the activities, I agree to abide by and to cause my guests to abide by all rules and policies of Providence Hill related to the Activities.

6. IN CONSIDERATION OF MY BEING PERMITTED TO ENGAGE AND/OR PARTICIPATE IN THE ACTIVITIES, AND AS A CONDITION OF THE RIGHT TO PARTICIPATE IN THE ACTIVITIES, I PERSONALLY ASSUME ALL RISKS INCIDENT TO SUCH ACTIVITIES. I ALSO WAIVE, RELEASE AND FOREVER DISCHARGE PROVIDENCE AND ALL OF THEIR EMPLOYEES, MANAGERS, MEMBERS, PARTNERS, OFFICERS, DIRECTORS, STOCKHOLDERS, CONTRACTORS OR AGENTS, INCLUDING JIMMY GRANT (COLLECTIVELY, THE "RELEASEES"), FROM ALL LIABILITIES, LOSSES, DAMAGES OR COSTS OF ANY NATURE THAT MAY ARISE IN CONNECTION WITH MY TRAVEL TO OR FROM,

ENGAGEMENT OR PARTICIPATION IN ANY OR ALL ACTIVITIES (INCLUDING RESCUE ACTIVITIES ASSOCIATED WITH THE ACTIVITIES), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR CAUSED BY SOME OTHER MEANS. I HEREBY AGREE NOT TO FILE SUIT AGAINST ANY OF THE RELEASEES. I AGREE TO INDEMNIFY AND HOLD THE RELEASEES HARMLESS FROM ALL LIABILITIES, LOSSES, DAMAGES OR COSTS OF ANY NATURE THAT MAY ARISE IN CONNECTION WITH MY TRAVEL TO OR FROM OR PARTICIPATION IN ANY OR ALL ACTIVITIES, INCLUDING RESCUE ACTIVITIES, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, OR OTHERS, OR CAUSED BY SOME OTHER MEANS. I SPECIFICALLY ACKNOWLEDGE THAT MY PARTICIPATION IN THE SHOOTING AND ARCHERY ACTIVITIES CARRIES THE RISK OF SHOOTING OTHERS AND/OR OF A BULLET OR OTHER SHOT LEAVING THE PROPERTY OR DESIGNATED SHOOTING AREA, WHETHER CAUSED BY MY NEGLIGENCE OR CAUSED BY SOME OTHER MEANS. I ASSUME ALL RISK FOR SUCH SHOOTING AND ARCHERY ACTIVITIES AND OF THE INJURY TO PERSON AND PROPERTY OF OTHERS FROM ANY AND ALL SUCH BULLETS AND SHOT. THE TERMS OF THIS DOCUMENT SHALL BIND ME, MY HEIRS, SUCCESSORS, ASSIGNS AND PERSONAL REPRESENTATIVES.

7. I have not been required to engage or participate in any or all of the Activities. I have freely chosen to do so. Prior to signing this document, I have had an adequate opportunity to read and understand it, have had an opportunity to ask questions about it, and any questions I have had have been answered to my satisfaction. I further state that I am 21 years or older and competent to sign this document.

8. This agreement shall be effective on a continuous basis beginning as of the date written below and shall cover and govern all Activities referred to herein from such date through the later of the second anniversary of such date or as long as I remain a member of the Sporting Club at Providence Hill Farm.
